- F. 2A-5A will advance the "Top 18" in each event.

- A. Participating in out of state meets will only be allowed based upon set criteria and approval by the CHSAA office.
- B. Meet results, entered into Maxpreps, must be verified within one week of submission. Any requests for change after this time frame will not be granted. (2018)
- C. All pole-vaulting coaches will be required to take the NFHS Safety Course to become registered. This needs to be completed every two years. (2018)
- D. A new four year rotation for the state meet schedule begins with the 2019 state championship.
